Requirements for programs and terms

The Chair of the NSW Prevocational Accreditation Committee (PAC) has written to training providers requesting the allocation of terms for 2024 be drafted and reviewed to ensure training provider programs align with the National Framework – Section 3 Requirements for prevocational training programs and terms.

Training providers have been previously asked to map individual terms to the requirements and these have now been approved by PAC.

This activity asks you to group five terms across the year for each PGY1 and PGY2 position. These must be currently accredited or provisionally accredited terms.






Introduction

There are a number of steps to ensure terms allocated for each PGY1 and PGY2 meet the program and term requirements.

Training providers are requested to complete the following tasks using the rotation planner spreadsheet provided.



ALLOCATE PROGRAM / TERMS

Training provider to allocate 5 provisionally or fully accredited terms for each prevocational doctor for 2024 into the spreadsheet provided

> Ensure clinical experiences rule is met

ENSURE SPECIALTY / SUBSPECIALTY RULE MET

Training provider to ensure that the specialty limits are not exceeded to ensure specialty rule is met

CLINICAL TEAM STRUCTURE RULE MET

Training provider to ensure that the allocated terms ensure trainees are embedded in a clinical team for 50% of the prevocational year

SERVICE TERM RULE MET

Training provider to ensure that the service term maximum is not exceeded.

No more than one service term per clinical year

ENDORSE WITH GCTC CHAIR AND SUBMIT TO HETI

Endorsed spreadsheets to be returned to HETI for approval by the PAC

PAC to review and provide feedback to training providers





Task one - Allocate program of terms

Under the National Framework, there are requirements for programs to provide clinical experiences as shown in the diagram when allocating terms for the clinical year.


Enter and review the 5 proposed terms for each PGY1 and PGY2, for 2024 into the spreadsheet provided.

For PGY1, the run of five terms should provide term classifications in a range of clinical experiences across A-D (assigned term classifications approved by the PAC).

For PGY2, the run of terms may provide a range of clinical experiences across A-E. Note that it is not mandatory for PGY2 doctors to be allocated terms providing clinical experience in D and E.

In addition to clinical experiences of A-D, PGY2s may also complete a term with non-direct clinical experience (E).

Note: It is not mandatory for PGY2 doctors to be assigned terms providing D and, E (non-direct clinical experience).




Task Two - Ensure specialty/subspecialty rule met

Under the National Framework there are limitations on the amount of time a trainee can spend in a specialty or subspecialty term.

Review specialty/subspecialty for the five allocated terms and ensure:

PGY1 A maximum of 50% in any specialty and 25% in a subspecialty for PGY1 doctors in the year.

PGY2 A maximum of 25% in any subspecialty in the year.







Task three - Clinical team structure rule met

Under the national framework, there is a requirement PGY1 and PGY2 doctors spend at least 50% of each year embedded within a clinical team.

Review the clinical team structure of the terms allocated for the year.


Task Four - Service term rule met

Service terms are generally relief terms or night duty-based terms. At the program level, there are limitations to the length of time prevocational trainees may spend in service terms during any clinical year. In NSW this is a maximum of one term per year.

Review the terms allocated for the year to ensure trainees are not allocated more than one service term.

PGY1 A maximum of one service term

PGY2 A maximum of one service term

Submit your program of terms for endorsement by the GCTC Chair.

Submit the endorsed rotation planner spreadsheet to HETI for review and approval by the Prevocational Accreditation Committee (PAC) by the due date.


